### Study tour of women entrepreneurs to Germany

During 28 june- 03 july 2015 AMFA ED being a Chair of ASK women enterpreneurship development commission have leaded a group of 4 women entrepreneurs from Azerbaijan in the regional study tour of women entrepreneurs to Germany. The Azerbaijani group was represented by 5 persons : Chair of the commission Ms. Jhale Hajiyeva, director of "Vekil Burosu" LLC Ms. Arzu Aliyeva, founder of "FFF+N" LLC Ms. Tajira Islamova, founder of Baku Textile Factory Ms. Sakina Babayeva and founder of "AIVA" LLC and "Epikur bagi" restaraunt Ms. Parvana Iskenderova. The study tour was financed by Meklenburg - Vorpommern Technical Vocational Training Institute.

In total 13 women entrepreneurs from Caucaus region have participated in this study tour. Since women entrepreneurs were representing various fields respective customised B2B meetings were arranged. Plenary meetings were organized with the head of the social policy and international relations for Europe of German Confderation of Entreprenerus ( BDA) Ms Renate Hornungdraus, in Bundestag, with the head of the Germany-East Caucasus friendship group among parliaments Ms. Karin Strenz and with the head of the Women Enterpreneurs Center Ms. Kristina Bannusher. Several interesting meetings were organized with organizations that specialized on facilitating business deals with postsoviet countries that accompained with presentation of specifics on doing business in Germany and with german companies, useful recommendations and suggestions as well as lessons learnt from previous deas were shared. During the study tour field visits were organized to factories of the german women in business (production of elevators and maintenance, production of construction materials, textile distribution firm and men's wear factory.



In addtion to meetings women entrepreneurs were offered seminars on "Import & export while doing business with Germany", "How to do selfmarketing?" that well equipped them with useful and practical advices and recommendations.

#### **TBC Kredit summarized the results for 2014**

During the reporting period, TBC Kredit has increased its loan portfolio by 14,8% compared to the end of December 2013. As of December 31, 2014 the portfolio had reached 47,5 million USD with 6082 active loans. The portfolio is comprised mainly of business loans - 46%, the share of consumer loans and mortgage - 39% and 15% respectively. Share of rural loans, financing of which began from July 2014 is 6% of total business loans portfolio.

In comparison with the previous year, volume of consumer increased.

During the reporting period, TBC Kredit increased its performance and established cooperation with new partners, attracted longterm borrowings, issued and successfully placed its own bonds in the amount of 3 million manats in Azerbaijan and 5 million. dollars of bonds in Georgia.

TBC Kredit LLC has a successful partnership history with foreign and local financial institutions when it comes to attraction of outside investment resources. For instance, in 2014 TBC Kredit LLC received several tranches in amount of \$15,6 mln that were directed to business lending development in Azerbaijan. Organizations such as MicroVest, ResponsAbilitySocial Investments AG, Triple Jump, OPIC (Overseas Private Investment Corporation, USA), European Bank for Reconstruction and Development (EBRD) and Black Sea Trade and Development Bank (BSTDB).

During 2014 TBC Kredit opened its branches in Sumgayit and Khachmaz, thus started to provide its services in the regions of Azerbaijan Republic. By opening a branch in Khachmaz, TBC Kredit began to finance a new type of loan in its portfolio – agricultural loan. In 2015 TBC Kredit plans to expand its activity in regions as well as opening new branches.
