UN Azerbaijan Strategic Priority Seminar

n January 17, 2020, the Executive Director of the Azerbaijan Microfinance Association, Jaleh Hajiyeva, contributed as a speaker at the high-level session of the UN Azerbaijan Strategic Priority Seminar. At the event, Jaleh Hajiyeva spoke about the value of the Azerbaijan-UN partnership and the basic features of sustainable development goals. During her speech, Ms. Hajiyeva also highlighted the important role of micro-finance organizations in achieving the SGP, and in this regard, the projects implemented jointly by the UN and AMFA and planned for the future.



"The growing experience of EU member states over the years shows that sustained stimulation of self-employment through microcredit allows people to participate in building the economy as well as wealth, poverty and social injustice, and contributes to the Sustainable Development Goals. New technologies, changes in the development of the service sector and self-governance are fundamentally changing the labor market. Self-employment has the advantage of allowing each individual to use his or her unique skills and abilities. "As the UN partnership with Azerbaijan adds value to the implementation of SGPs, supporting economic activity, developing entrepreneurship, increasing employment, increasing household consumption opportunities and eliminating income inequality, it is necessary to continue UN support in this direction"



FACILITATING "OPEN MEDIA THINK TANK EVENT"

On March 6, 2020, the Delegation of the European Union (EU) to Azerbaijan, in cooperation with the EU Neighbors East Project, organized an informal meeting entitled "Open Media Think Tank Event" for representatives of leading media outlets operating in Azerbaijan. AMFA Executive Director Jala Hajiyeva moderated in this event. The main purpose of the meeting was to discuss the tangible results and opportunities created by EU projects in the lives of Azerbaijani women. Ambassador Kestutis Jankauskas - Head of the EU Delegation to Azerbaijan, representatives of the United Nations Development Program (UNDP) and the United Nations Population Fund (UNFPA), journalists, bloggers, EU-funded project managers, EU-supported women and Young European Ambassadors has attended in the event.







The European Union has been working tirelessly for more than 60 years to protect women's rights and empower them to reach their full potential. Gender equality is main goals of the EU's Eastern Partnership initiative. This is important in the personal lives of both women and men, and is crucial for long-term democratic development. In cooperation with Azerbaijan, the EU promotes real change by strengthening business women, creating opportunities for quality education and promoting democratic society. Funds are allocated for special activities under these projects, which aim to support Azerbaijani women and create conditions for economic development in the regions. This meeting is an invaluable opportunity for the media and EU project representatives to get to know each other better and to strengthen cooperation to better inform Azerbaijani women about EU-funded projects.

PROJECT NEWS

Supporting Empowering Women

On January 28, 2020, the final conference of the project "Empowering Women for Sustainable Development" funded by the European Union and partially funded by the UN Development Program was held in the Nakhchivan Autonomous Republic. The main goal of the year-long project was to increase access to entrepreneurship and microfinance services for women and other groups with special needs in the Nakhchivan Autonomous Republic and Ismayilli region. The project beneficiaries' Fair-exhibition was organized with organizational support of the State Committee for Family, Women and Children Affairs of the Autonomous Republic of Nakhchivan.



Women entrepreneurs presented their products at the fair during the final conference of the project. More than 1,600 products were presented at the exhibition. The participants and guests of the conference demonstrated great interest to the exhibition.



The project provided a wide range of training opportunities for women in cash management, budget planning, business management, debt management and other skills required to start a new business, and supported their economic empowerment and financial independence. This project conducted by AMFA has been implemented in the framework of the larger scale program "Promoting the Role of Civil Society in Gender-sensitive Implementation of the Sustainable Development Goals" and funded by the European Union (EU), partly funded by the United Nations Development Program (UNDP).



The project helped to improve business skills, financial literacy, and access to financial resources, and organizational skills of 390 women from rural communities, including women with special needs. 78 women with the best business ideas have been provided with investment capital to start business in Nakhchivan AR and Ismayilli region. In support of Azerbaijan's commitment to accelerate the implementation of the 2030 Agenda for Sustainable Development and the Sustainable Development Goals (SDGs), the project has implemented the 4th (quality education), 5th (gender equality) and 8th (good jobs and economic growth) has contributed to the achievement of the Global Goals.



Speaking at the final conference of the project in Nakhchivan, the Chairman of the State Committee for Family, Women and Children of the Nakhchivan Autonomous Republic Ramila Seyidova made the opening speech. Ms. Ramila Seyidova highlighted the importance of the development of women's entrepreneurship for the Nakhchivan Autonomous Republic and its positive impact on the economic and social development of the Autonomous Republic.



Mr. Jalal Aliyev, Chairman of the Board of the Azerbaijan Microfinance Association, mentioned the importance of developing sustainable microfinance in the country, especially agriculture. Ms. Jala Hajiyeva, Executive Director of the Azerbaijan Microfinance Association, welcomed the conference participants. She mentioned the project helped to increase economic and social prestige and eliminate gender inequality. Project Manager of the Azerbaijan Microfinance Association Sevinj Rustamova shared the successful results of the project with the participants. Ms. Sevinj Rustamova noted that the project has achieved both the development of entrepreneurship and the development of knowledge and skills of the entrepreneurs. In conclusion, one of the project participants, Ms. Aygun Bayramova, talked about the impact and benefits of the project for women who want to start a business. As a result of the committee's support, 63 women have started their own businesses.

CLARA - "Cash Flow-Linked Agri Risk Assessment" tool related training sessions were organized by IFC for banks in Ganja, Lankaran, Khachmaz and Sheki cities, as well as for non-banking credit organizations that are AMFA Members and have joined this tool.

WHAT IS CLARA? - CLARA is a web-based Cashflow Linked Agriculture Risk Assessment tool that has been developed by IFC, a member of the World Bank





This tool is mainly used by banks and non-banking credit organizations to expand their credit portfolio on agriculture through a more effective assessment of the agricultural borrowers' creditworthiness. IFC's Azerbaijan Investment Climate and Agribusiness Competitiveness Project, funded by SECO, in cooperation with AMFA is providing capacity building workshops for MFIs on the use of CLARA for agri-lending.

Supporting microfinance industry through lobbying activities

AMFA's Board and Executive Office continue to work intensively fot the recognition of MFIs as a part of the financial market. In this regard, negotiations and discussions are being held at various levels with the National Confederation of Enterpreneurs, Ministry of Economy of Republic of Azerbaijan, Entrepreneurship Development Fund, Central Bank, Agro Credit and Development Agency. Taking into account the current pandemic situation, association /approached the Central Bank of the Republic of Azerbaijan to provide appropriate assistance to extend the deadline for applications of individuals for the conclusion of a new soft loan agreement for the restructuring of credit debts until December 31, 2020 and to the President of the National Confederation of Entrepreneurs (Employers) of the Republic of Azerbaijan to provide appropriate assistance for the inclusion of Non-Bank Credit Institutions (MFCs) and Leasing Companies in the list of organizations that will be able to perform their activities during the special quarantine regime. Thus, as a result of several AMFA's initiatives, non-Bank Credit Institutions (MFCs) and Leasing Companies engaged in agricultural activities have been also included in the list of institutions that can operate in the quarantine period in the territory of the Republic of Azerbaijan and being suffering from pandemics eligible to benefit from the state guarantees for , subsidies on loan interest rates, elimination of fees paid by MFİs to the financial market supervisory authority has been approved.
