Baseline Study results were presented within

USAID AFA Activity





Within the framework of the USAID "Associations for Future Activity" project implemented by the Azerbaijan Micro-finance Association (AMFA), funded by the United States Agency for International Development (USAID), implemented jointly with the Union of Disability Organizations (UDPO) and "Finance and Social Innovation Consulting" (FSIC) certain progress was achieved during November.

On November 22, 2022, the Azerbaijan Micro-finance Association (AMFA) hosted a round table event called "Pause and Reflect Session Year 1" within the USAID AFA project.

The main purpose of the event was to present the results of the Baseline Study, the application and selection process of potential beneficiary associations. Baseline Study was conducted by Consortium partner Finance and Social Innovation LLC in consultation with various industry partners, including business and professional associations, government agencies interested in the development of the sector, and international development institutions. Research tools such as online survey, focus group discussions, interviews and research were used to prepare the report.

During the event, the AFA team made a presentation about the results of the Baseline Study, the application and selection process of potential associations. The representatives from the Ministry of Agriculture of the Republic of Azerbaijan, SMBA, who participated in the event, brought to the attention of the committee their suggestions that would have a positive effect on the progress of the project.

"Educate women for family welfare" project has been completed!

On November 23, 2022, the Closure Conference of the "Educate women for family welfare" project was held in Nakhchivan Autonomous Republic. The project funded by the Swiss Development and Cooperation Agency, was implemented by the Azerbaijan Micro-finance Association (AMFA) in partnership with the State Committee on Family, Women and Children's Affairs of Nakhchivan AR.

The main goal of the year-long project was to create self-employment opportunities for low-income women living in Nakhchivan Autonomous Republic, including women with disabilities, by equipping them with the necessary skills and seed capital.

Within the framework of the project, a wide range of training opportunities were created for women related to money management, budget planning, business management, debt management methods and other skills required for building a new business, and support was provided to increase their economic empowerment and ensure financial independence. The project helped improve financial literacy, business skills, access to financial resources and organizational skills of 70 women from rural communities, including women with disabilities. 64 women with the best business ideas were provided with the seed capital to start entrepreneurial activities in the Nakhchivan Autonomous Republic.

Meeting with CIPE Center for International Private Enterprise) on WNBA





On November 1, 2022, under the leadership of the Azerbaijan Micro-finance Association (AMFA), a meeting was held between CIPE (Center for International Private Enterprise) Regional Director of European and Eurasian Department Natalia Otel Belan, CI-PE Caucasus and Moldova program specialist Anna Goltermann and the 3rd component head of the PSA project Shalala Kamilova.

During the meeting, the importance of the Women's National Business Agenda prepared with the participation of AMFA was discussed. At the same time, the representatives of the CIPE organization discussed the possibilities of cooperation by providing extensive information about the activities of the Women's Economic Empowerment Center.

At the end of the meeting, views were exchanged on the difficulties faced by business associations operating in the country and their solutions. The representatives of the CI-PE organization also informed about the start of the next new project in Azerbaijan and emphasized the use of possible cooperation opportunities with AMFA in that project.

The implementation of the recommendation document on WNBA has started



On November 3, 2022, the Executive Director of the Azerbaijan Micro-finance Association, Jhale Hajiyeva, spoke as a speaker at the United States Agency for International Development (USAID) event called "Starting the implementation of the Women's National Business Agenda for Women's Economic Empowerment". At the event, the WNBA recommendation document was presented, which offers concrete recommendations and policy solutions for creating a favorable business environment for women and eliminating the problems they face in the workplace. In addition, the report of the survey on Women's Entrepreneurship in Azerbaijan within the framework of the project was brought to the attention of the participants.

At the end of the event, members of the Steering Committee, consisting of business association and organization leaders, who were closely involved in the preparation of the WNBA recommendation document performed with their suggestions and opinions, participated in a panel discussion and shared their views on how this coalition affects their activities in the direction of women's empowerment, and about their contributions to the development of the WNBA.

On November 4, 2022, the Executive Director of the Azerbaijan Micro-finance Association, Jhale Hajiyeva, participated in a meeting with the USAID Deputy Administrator Erin McKee and Assistant to the Deputy Administrator for Europe and Eurasia Bureau Dr. Alexander Sokolovski and women working in the field of women's entrepreneurship development.

At the meeting, interesting ideas were exchanged about the development of the potential of women's entrepreneurship in Azerbaijan.

On November 11, 2022, the Azerbaijan Micro-finance Association participated in the "Issuer's Day" event organized by the Baku Stock Exchange for the first time in Azerbaijan. "International Bank of Azerbaijan" OJSC acted as the issuer at the meeting attended by "Central Bank of the Republic of Azerbaijan", "Baku Stock Exchange" CJSC, "National Depository Center of the Republic of Azerbaijan" and "ABB-Invest Investment Company" CJSC.

The main objective of the event is to convey the advantages of the organized capital market to investors and potential issuers. During the event, the International Bank of Azerbaijan, an active participant of the organized capital market in Azerbaijan, shared its experience on the market with the meeting participants. The presenters of the meeting, in turn, informed the meeting participants about the possibilities of organized capital markets, which are an alternative source of financing. Companies with securities listed on the Baku Stock Exchange, potential issuers: banks, non-bank credit organizations, insurance companies and companies from other fields participated in the event as listeners.


